1 Introduction

2 Key terms

- **Processing** means any operation which is performed on personal data, such as collecting, storing, viewing, sharing or otherwise using personal data.

your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal and regulatory requirements.

8 What are your data protection rights?

Depending on your location, in certain circumstances you may be able to exercise certain rights in relation to your personal data. These rights may include the right to:

Right of access

You have the right to request a copy of the personal data that we hold about you. This right is also known as a 'data subject access request' or a 'DSAR'.

Right of rectification

You have the right to have inaccurate or incomplete personal data corrected.

Right to be forgotten

You have the right to ask us to erase your personal data.

Right to restriction of processing

You have the right to ask us to restrict our processing of your personal data.

Right of portability

You have the right to ask us to transfer your personal data to another organisation, in a structured and machine-readable format.

Right to object

You have the right to object to our processing of your personal data.

Right to object to automated processing, including profiling

You have the right not to be subject to a decision based solely on automated processing, which produces a legal or similarly significant effect on you.

Right to withdraw consent

You have the right to withdraw your consent at any time, for the purposes for which we obtained your consent.

9 How can you make a complaint?

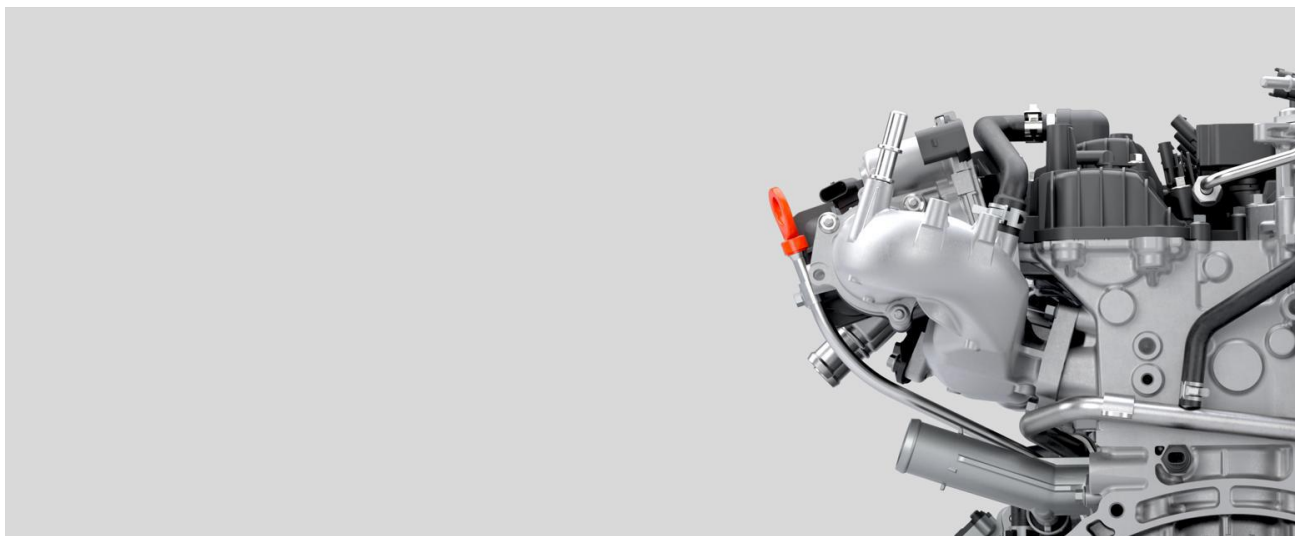


10 Information for Chinese Residents
